**SIXTH AMENDMENT TO AMENDED AND RESTATED  
MASTER DECLARATION FOR SOLIVITA™**

THIS SIXTH AMENDMENT TO AMENDED AND RESTATED MASTER DECLARATION FOR SOLIVITA™ (this "Sixth Amendment") is made this 27 day of January, 2020, by Avatar Properties Inc., a Florida corporation ("Developer") and joined in by Solivita Community Association, Inc., a Florida not-for-profit corporation ("Association").

RECITALS

- A. That certain Amended and Restated Master Declaration for Solivita™ was recorded in Official Records Book 9142 at Page 1843 through 2018, as amended by virtue of that certain First Amendment to Amended and Restated Master Declaration for Solivita™ recorded in Official Records Book 9811 at Page 570, Second Amendment to Amended and Restated Master Declaration for Solivita™ recorded in Official Records Book 9952 at Page 41, Third Amendment to Amended and Restated Master Declaration for Solivita™ recorded in Official Records Book 10401 at Page 1687, Fourth Amendment to Amended and Restated Master Declaration for Solivita™ recorded in Official Records Book 10668 at Page 55, and the Fifth Amendment to Amended and Restated Master Declaration for Solivita™ recorded in Official Records Book 10842 at Page 1196, all of the Public Records of Polk County, Florida (collectively, the "Amended and Restated Master Declaration") respecting the residential community known as Solivita ("Community").
- B. Section 5.3 of the Amended and Restated Master Declaration provides that, prior to the Turnover Date (as defined in the Amended and Restated Master Declaration), Developer, shall have the right to amend the Amended and Restated Master Declaration as it deems appropriate, without the joinder or consent of any person or entity whatsoever. The Turnover Date has not yet occurred.
- C. Section 6.1 of the Amended and Restated Master Declaration provides that, prior to the Turnover Date (as defined in the Amended and Restated Master Declaration), Developer has the right to annex additional lands to the Community without the joinder or consent of any other party by the recording of an amendment to the Amended and Restated Master Declaration. The Turnover Date has not yet occurred.
- D. Developer desires to amend the Amended and Restated Master Declaration as set forth herein.

NOW THEREFORE, Developer hereby declares that every portion of the Community is to be held, transferred, sold, conveyed, used and occupied subject to the covenants, conditions and restrictions hereinafter set forth.

1. Recitals. The foregoing Recitals are true and correct and are incorporated into and form a part of this Sixth Amendment.
2. Conflicts. In the event that there is a conflict between this Sixth Amendment and the Amended and Restated Master Declaration, this Sixth Amendment shall control. Whenever

possible, this Sixth Amendment together with the Amended and Restated Master Declaration shall be construed as a single document. Except as modified hereby, the Amended and Restated Master Declaration shall remain in full force and effect.

3. Definitions. All initially capitalized terms not defined herein shall have the meanings set forth in the Amended and Restated Master Declaration, except that the defined terms are hereby modified as follows:

"Declaration" shall mean the Amended and Restated Master Declaration, the First Amendment, the Second Amendment, the Third Amendment, the Fourth Amendment, the Fifth Amendment and this Sixth Amendment together with all amendments and modifications thereof.

4. Annexation. The real property described in Exhibits A-1 and A-2 attached hereto is hereby annexed into and made a part of the real property described in Exhibit 1 of the Amended and Restated Master Declaration and, as such, is part of the Community and is subject to the provisions of the Declaration and the jurisdiction of the Association.

5. Legal Description. The real property described in Exhibit 1 of the Amended and Restated Master Declaration is hereby deleted in its entirety and replaced with the real property described in Exhibit B attached hereto.

6. Covenant. This Sixth Amendment shall be a covenant running with the land.

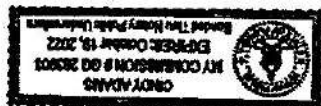

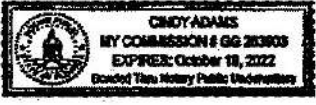
